The Financial Part shall remain unopened and will be held in safe custody of the Employer until the second public opening of the Financial Part, following the evaluation of the Technical Part of the bids.

4.applicant should present a copy of valid tax card.

5.applicant should present a copy of sales tax certificate.

6.applicant should present copy of insurance card + valid zakat card.

7.applicant should present a copy of profession practicing license.

8.The applicant must commit to paying taxes according to the laws in force in the country

9.An unconditional bank guarantee valid for the above mentioned period shall be attached to the bid, or a payable cheque for the amount specified above, valid for the above mentioned period starting from the date of the bid opening. Any bid not accompanied by a bid guarantee will be rejected.
